This program is being offered for **4 year olds (potty learned) – 12 year olds**. Hours will be **Monday through Friday, 7:30 a.m. – 5:30 p.m.** **Thirty (30) spots are available so act soon.**

Summer Fun & Enrichment Camp

St. Mary's Summer Camp is a faith-based full day camp for ages 4 to 12 years Monday – Friday. We are a structured program that has been designed to keep your child engaged, learning and busy throughout the day. Our Summer program community embraces the Gospel values of love of God, service to neighbor, formation in the Catholic family and moral principles, and the development of personal integrity and character. There will be weekly field trips and daily activities. Your child(ren) will be in a safe environment with all employees having a DFS background check, CPR/First Aide training, Diocese background check along with Safe Environment training. St. Mary's is a secure facility and a loving environment. Each child will be required to have an information sheet on file.

Registration:

- A \$50 dollar Registration Fee per family is required at the time your application is submitted. If you end up not attending St. Mary's Catholic Summer Program your registration fee will not be returned.

Tuition Costs:

St. Mary's Summer Camp total charges will be \$1,300 broken up into two payments. All activity fees and expenses are included in the tuition charge. First payment of \$650 is required on or before June 2, 2017 and the second payment of \$650 is required on or before June 30, 2017. However, there is also an option to pay the full amount of \$1,300 on or before June 2, 2017.

If you are registering a second or third child we will offer a \$130 discount for each additional sibling. The total cost for the second child will be \$1,170 and third child will be \$1,040.

1st Payment covers:

June 5 to June 30, 2017

Failure to pay by Monday, June 5th will result in your child(ren) not being allowed to attend until payment is received. If payment is not received by Wednesday, June 7th your child(ren) slot(s) will be forfeited and given to another child(ren).

2nd Payment covers:

July 5 to August 4, 2017

(Closed July 3rd and July 4th to celebrate the 4th of July Holiday)

(Closed July 24th -28th for Cheyenne Frontier Days)

Failure to pay by Wednesday, July 5th will result in your child(ren) not being allowed to attend until payment is received. If payment is not received by Friday, July 7th your child(ren) slot(s) will be forfeited and given to another child(ren).

Days and Times:

June 5, 2017 to August 4, 2017

Closed Monday, July 3rd, Tuesday, July 4, 2017 and July 24-28, 2017

Monday – Friday

Drop-off Times: NO EARLIER than 7:30 a.m.

Pick-up Times: NO LATER than 5:30 p.m.

Failure to pick up by 5:30 p.m. will result in a late fee of a \$1.00 per minute per child. All late pick-up charges will be billed out monthly.

Failure to pay as negotiated:

- Payment of tuition and fees are due as specified in the above agreement of this contract.
- Payment is expected on or before the scheduled due date. There will be a service charge of \$25.00 for all non-sufficient funds.
- Failure to make accounts current, may result in dismissal of the child(ren) from St. Mary's Summer Camp.
- Collection efforts of delinquent accounts will continue after removal of the student from the program.
- All expenses, including attorney fees, related to the collection of outstanding and/or overdue accounts will be added to the balance owed on delinquent accounts.

Withdrawal Guidelines

- Families must notify the school in writing if a child(ren) is to be withdrawn from St. Mary's Summer Camp.

NEW Families:

If you are a new family to St. Mary's and would like to attend an activity that is planned during our St. Mary's Summer Camp you must have an approved BACKGROUND CHECK on file along with Safe Environment Training that is a Diocesan requirement. There are NO EXCEPTIONS to this rule.
